
AMERICAN IDOL TRUE BELIEVER Program
Official Rules for Designated “True Believers”

If an American Idol contestant designates you as a “True Believer”, to accept and participate, you must agree to these Official Rules.

DESCRIPTION: NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. The “AMERICAN IDOL True Believer Program” (“**Program**”) is a Program run in conjunction with Season XIV of the television program *American Idol* (“**AI**”). The Program begins on Wednesday, June 18, 2014 at 8:00 am Eastern Time (“**ET**”) and ends on or about the initial airing of the Season XIV AI Finale, tentatively scheduled to air in or around mid-May, 2015, but subject to change as a result of broadcast schedule (“**Program Period**”). The sponsor of this Program is American Idol Productions, Inc. (“**Sponsor**”).

YOU MUST BE DESIGNATED BY A SEASON XIV AI PARTICIPANT AND CONSENT TO THESE OFFICIAL RULES IN ORDER TO PARTICIPATE IN THE PROGRAM. NO OTHER FORM OF ENTRY OR REGISTRATION IS AVAILABLE.

The Program will be conducted as follows:

- **True Believer Designation:** At a certain round in the Season XIV AI competition, to be determined by Sponsor in its sole discretion, Sponsor will request that each AI participant (collectively, “**AI Participants**”) designate one (1) person from that AI Participant’s life who the AI Participant considers to be a “True Believer” of that AI Participant (“**True Believer**”). AI Participants are not required to designate a True Believer. If an AI Participant chooses to designate you as his or her True Believer, then you will be contacted by Sponsor per Paragraph 4 below.
- **True Believer Consent:** Each person designated as a True Believer by an AI Participant must give consent to be a True Believer, sign and complete all necessary paperwork as required by Sponsor, and agree to these Official Rules. You will not be officially entered into the Program unless and until you agree and consent to be designated as a True Believer.
- **Winner Determination:** If the AI Participant who wins Season XIV of AI has designated a True Believer, subject to these Official Rules, including Paragraph 2 below, such True Believer will be deemed the winner of the Program (“**Winner**”). If the AI Participant who wins Season XIV of AI did not designate a True Believer, Sponsor shall donate the Prize to a charity of its own choosing.
- **Winner Notification:** Winner will be notified by Sponsor during or after the initial airing of the Season XIV AI Finale, tentatively scheduled to air in or around mid-May, 2015, but subject to change as a result of broadcast schedule. Check local listings for complete broadcast schedule.
- **Prize:** The prize for winning the Program is US \$50,000 (Fifty Thousand US Dollars).

2. ELIGIBILITY: To participate in the Program you must: a) be a U.S. citizen, legal permanent resident of the U.S. (excluding Puerto Rico and other U.S. territories or possessions); b) not currently be a candidate for public office, and if designated as a True Believer, you agree not to become a candidate for public office until at least one (1) year after the initial broadcast of the final episode of Season XIV of AI; c) not be the child or ward of the AI Participant who designates you as his or her True Believer; and d) be willing to voluntarily submit to a background check. Any person who is under the age of eighteen (18), or is a minor in his or her state of residence, must have his or her parent’s or legal guardian’s permission to participate in the Program in order to be eligible to participate in the Program.

Employees, shareholders, officers, directors, agents, and representatives of Sponsor, 19 Recordings, Inc., 19 Entertainment Ltd., 19 Entertainment, Inc., 19 Touring LLC, CORE Media Group Inc., or 19 TV Limited (collectively, the “**19 Companies**”), Fox Broadcasting Company (“**FOX**”), Twenty-First Century Fox, FremantleMedia North America, Inc. (“**FremantleMedia**”), Universal Music Group, Interscope Records, Telescope Inc., www.fox.com, www.americanidol.com, any Season XIV sponsors of AI as may be identified by Sponsor or any of their respective parents, subsidiaries or affiliated companies, or any of their respective licensees, successors, or assigns; CBS Television City Studios, or any other person or entity connected with the production, administration, or judging of the auditions or Season XIV of AI; any television station or channel, cable network, or satellite network that may air or otherwise exhibit Season XIV of AI or any variation thereof; any person or entity involved in the development, production, distribution, or other exploitation of Season XIV of AI or any variation thereof; any sponsor of Season XIV of AI or its or their advertising agencies; or any person or entity supplying services or prizes to Season XIV of AI (collectively the “**Program Entities**”) shall not be permitted to participate or be named as True Believers. Program void where prohibited.

People who are designated by AI Participants and who do not meet the above requirements may be deemed ineligible to receive the Prize at the Sponsor's sole discretion. Sponsor reserves the right to determine in its sole discretion which people have satisfied the eligibility requirements. AI PARTICIPANT MUST SUBMIT AN ELIGIBLE TRUE BELIEVER IN ACCORDANCE WITH THESE OFFICIAL RULES AND FOLLOW ALL TERMS OR ADDITIONAL REQUIREMENTS AS MAY BE SET FORTH ON THE TRUE BELIEVER DESIGNATION FORM PROVIDED BY SPONSOR.

3. DESIGNATION AND NOTIFICATION: AI Participants may only designate one (1) True Believer during the Program Period, at the time specified by Sponsor in its sole discretion. Once designated, the AI Participant may not change, substitute or otherwise amend its True Believer designation. Program Period will run and Winner will be determined on or about the dates outlined above.

True Believers will be notified via email at any time throughout the Program Period and must respond within three (3) days of notification. Upon notification, True Believers must respond by telephone to the contact number provided in the notification. Messages may not be left. Sponsor reserves the right to disqualify anyone not fully complying with the Official Rules or meeting the participation criteria. True Believers will be required to respond to the notification as set forth above and/or as directed by the Sponsor, and complete any necessary releases or permissions (as permitted by law). The failure to respond to the notification as determined by Sponsor in its sole discretion may result in disqualification. Each True Believer (or such True Believer's parent or legal guardian, if he/she is a minor) will be required to verify his or her address and to return within five (5) days all necessary paperwork, including but not limited to, a personal release, a background questionnaire, proof of identity, and a prize affidavit, covering eligibility, release of liability, and rights to use his or her name and likeness. A person will not be officially declared a True Believer until all required paperwork is signed and returned, and Sponsor deems such person eligible.

4. PRIZE: The Winner will receive one (1) lump sum payment of US \$50,000 (Fifty Thousand US Dollars) in the form of a check made out to the Winner ("Prize"). Odds of winning the Prize depend upon the total number of AI Participants.

ALL FEDERAL, STATE AND LOCAL TAXES, AND ANY OTHER COSTS AND EXPENSES, ASSOCIATED WITH THE RECEIPT OR USE OF THE PRIZE ARE THE SOLE RESPONSIBILITY OF THE WINNER. Winner cannot assign or transfer the Prize to another person, except at the sole discretion of Sponsor. Sponsor and Program Entities shall have no responsibility or liability for cancellations, delays, or any other change by any company or person providing any element of Prize due to reasons beyond the control of the Sponsor and Program Entities, and are not responsible or liable for any expenses incurred as a consequence thereof. Date and/or time of taping of AI are subject to change.

AI is subject to cancellation and scheduling delays. If AI is not produced or is cancelled for any reason, no Prize will be awarded. Other restrictions may apply. The Prize is awarded WITHOUT WARRANTY OF ANY KIND, express or implied, without limitation.

These Official Rules and the Program itself are neither an application nor a contract for employment.

5. WINNER NOTIFICATION: The potential Winner will be contacted via phone, email or overnight mail. Winner may be required to complete additional paperwork, specifically related to the Prize, at the sole discretion of the Program Entities. Program Entities reserve the right to disqualify anyone not fully complying with the Official Rules. Winner will be required to respond as set forth in Paragraph 2 above and as directed by the Program Entities to the notification. The failure of delivery of notification or the Prize, any failure to respond in the amount of time designated by the Sponsor at the time of notification or the potential Winner's rejection of the Prize may result in forfeiture of the Prize and, in such case, Program Entities may select as an alternate Winner the designee of the runner up AI Participant in Season XIV of AI.

6. WAIVER OF EQUITABLE RELIEF: Each True Believer (or the parent/legal guardian of any person who is a minor in his/her state of residence, on behalf of such minor) acknowledges that, with respect to any claim by such person relating to or arising out of a Program Entity's actual or alleged exploitation or use of that True Believer's name, likeness and/or biographical material or other material submitted in connection with the Program, the damage, if any, thereby caused to the applicable True Believer will not be irreparable or otherwise sufficient to entitle such person to seek injunctive or other equitable relief or in any way enjoin the production, distribution, exhibition or other exploitation of Season XIV of AI, and the True Believer's rights and remedies in any such event shall be strictly limited to the right to recover damages, if any, in an action at law.

7. RIGHTS OF PROGRAM ENTITIES/ DISCLAIMER OF LIABILITY: Program Entities also reserve the right, in their sole discretion, to adjust times and dates set forth in the Official Rules at any time and/or to terminate the Program for any reason in the event that there is an error, problem or cause which impacts the operation, administration or security of the Program or the Program Entities, and, in such situation, to select the Winner via a method and manner deemed fair and appropriate by Sponsor. The Program Entities are not responsible for any materials provided by any AI Participant and/or any True Believer designated by an AI Participant that are deemed harmful or offensive to others or for any harm incurred as a result of the submission. The Program Entities are not

responsible in any way for any injury, loss or damage which occurs as a result of an opinion expressed or information provided by any representative of the Program Entities. The Program Entities make no warranties, express or implied, as to the content or the accuracy or reliability of any information or statements contained in any submission by either AI Participants and/or their designated True Believers. All statements made by, and opinions of the AI Participants and True Believers are those of such AI Participants and True Believers only, and the Program Entities neither endorse nor shall be held responsible for the reliability or accuracy of same.

8. INDEMNITY: The Program may also be promoted by a third party or parties (each a “**Promotional Partner**,” collectively “**Promotional Partners**”). Each True Believer and/or AI Participant (or the parent/legal guardian of any participant who is a minor in his/her state of residence, on behalf of such minor) shall indemnify, defend and hold harmless the Program Entities, any Promotional Partners, and each of their respective parents, affiliates, successors, assigns and licensees, and each of their respective employees, shareholders, officers, directors, contractors, agents and representatives from and against any and all liability, claims, loss, damage, injury or expense, including reasonable attorneys’ fees, arising out of or in connection with any action arising out of or resulting from (i) the participant’s participation in the Program, (ii) a breach or allegation which if true would constitute a breach, of any of participant’s representations, warranties or obligations herein, (iii) acceptance, possession, or use/misuse of any grant or prize (or any portion thereof, including any travel related thereto), including without limitation, personal injury, death and property damage arising therefrom; (iv) any claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trademark infringement or any other intellectual property-related cause of action.

9. GENERAL TERMS AND CONDITIONS: By participating, each person agrees that the Program Entities and each of their respective agents, representatives, parent companies, affiliates, subsidiaries and legal advisors, and each of their respective employees, shareholders, officers, and directors are not responsible or liable for, and shall be released and held harmless from: (i) late, lost, delayed, damaged, incomplete, illegible, unintelligible, misdirected or otherwise undeliverable mail, postage-due notices, release forms, affidavits or other correspondence; (ii) telephone, electronic, hardware or software program, network, Internet or computer malfunctions, failures, or difficulties of any kind; (iii) any condition caused by events beyond the control of the Program Entities that may cause the Program to be disrupted or corrupted; (iv) any printing, human, typographical or other errors or ambiguities in (or involving) any materials associated with the Program; and (v) any and all losses, damages, rights, claims and actions of any kind in connection with or resulting from participation in the Program. Program Entities reserve the right, in their sole discretion, to suspend or cancel the Program at any time for any reason, including, without limitation, if a computer virus, bug or other technical problem corrupts the administration, security, or proper conduct of the Program, strikes, lock-outs, acts of God, technical difficulties, and other events not within the reasonable control of Program Entities. Program Entities reserve the right, in their sole discretion, to prohibit any participant from participating in the Program or to disqualify any individual they find, in their sole determination, to be tampering with the entry process or the operation of the Program; to be attempting to undermine the legitimate operation of the Program by cheating, hacking, deception, or any other unfair playing practices; to be acting in violation of these Official Rules; or to be acting in a disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. Program Entities may suspend or discontinue the Program if, in their sole opinion, there is any actual or suspected tampering relating to the Program, or any other malfunction, event or activity that may affect the integrity of the Program. PROGRAM ENTITIES SHALL NOT BE OBLIGATED TO AWARD ANY PRIZE THAT RELATES TO OR ARISES OUT OF IMPROPER OR MISTAKEN PRIZE NOTIFICATION, OPERATION OR FUNCTION OF THIS PROGRAM.

10. DISPUTES: All issues and questions concerning the construction, validity, interpretation and enforceability of the Program, or the rights and obligations of participants and the Program Entities in connection with the Program, shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of California or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of California. In the event of a claim or dispute, participants sole remedy shall be limited to their remedy at law for damages, if any, and participants shall not have the right to in any way enjoin or restrain the distribution, advertising, publicizing or other exploitation (in any form of media) of the Program, AI, and/or any intellectual property owned or licensed by the Program Entities or their respective parent and subsidiary companies and affiliated entities.

11. PRIVACY POLICY: Any personal information supplied by you to Sponsor will be subject to Administrator’s privacy policy posted at <http://www.fremantlemedia.com/privacy.aspx>. By entering the Program, you grant Sponsor permission to share your email address and any other personally identifiable information with the other Program Entities for the purpose of prize fulfillment. Sponsor will not sell, rent, transfer or otherwise disclose your personal data to any third party other than as explicitly described herein.

12.
